## **Objective and Scope**

In line with requirements of Code of Corporate Governance, the Board (BOD) has developed Whistle Blowing Policy.

The Whistle Blowing Policy formalizes the company's commitment to enabling it's all stake holders including employees, certificate holders, customers, vendors and other business associates to make fair and prompt disclosure of circumstances where it is genuinely believed that the company's business is being carried out in an inappropriate manner or in violation of applicable laws, or the company's policies, procedures, values.

## Whistle Blowing

The original voluntary/protected disclosure, in public interest by Whistle Blower, on an ongoing, suspected, or anticipated malpractice resulting in contravention of administrated legislation by the Company or regulated person.

Whistle blower includes any natural person who provides voluntary disclosure, in good faith.
